COVID-19 emergency – First clarifications about the procedure to require the benefits provided by the Law Decree Cura Italia

## Focus on...

We are hereby informing you on the first clarifications by INPS about the procedure to require some benefits provided by by Law Decree no. 18 dated 17-03-2020.

Given the Coronavirus emergency, the social security entity introduced a simplified procedure to require some benefits introduced by the Law Decree Cura Italia.

Specifically, this simplified procedure refers only to the following actions:

- allowance for professionals having a VAT registration number and for coordinated and continuative collaborators:
- allowance for self-employed craftsmen and tradesmen
- allowance for workers in the tourism sector and thermal facilities sector
- allowance for workers in the agricultural sector
- allowance for workers in the show and entertainment sector
- voucher baby sitting.

This New procedure allows to complete and to submit the request, after entering only part of the PIN code, received via SMS or e-mail, after having requested it through the portal or the Contact Center.

The PIN code can be required trough the following channels:

- INPS web site, via "Richiesta PIN" service
- Contact Center, calling the toll number 803 164 (free from fixed network), or 06164164 (paid service for mobile phone).

As soon as received (via SMS or email) the first eight characters of PIN code, the beneficiary can use immediately these characters to fill and to submit the request about the benefits above mentioned. In case of the beneficiary does not receive these characters by 12 hours from their request, he can call Contact Center for the validation of the PIN code.

Regarding only the voucher baby-sitting, if the beneficiary has submit the request of this voucher using the above simplified procedure, he must receive also to second part of the PIN code, useful to the registration on Libretto Famiglia service, in order to use the voucher.

Regarding the other benefits provided by the Law Decree Cura Italia (i.g. extraordinary leave), the procedure for the request is the ordinary one:

- Ordinary PIN code (PIN dispositivo)
- SPID di livello 2 o superiore
- Electronic Identity Cart (CIE)
- Carta Nazionale dei Servizi (CNS).

The social security entity provided that in the next days a new procedure of PIN code's request will be available, in order to give the possibility to people to obtain, by only one process, a new PIN code, without waiting for the additional 8 characters of the PIN that were ordinarily sent through the postal service.
